Name</b> The Union will be called, "The National Dairy Research Institute (Deemed University) Students' Union" (hereafter referred to as NDRI (SU) after the name of the Institute, the National Dairy Research Institute, Karnal.</p>	<p><b>Article 1. Name</b> The Council will be called, "<b>The National Dairy Research Institute (Deemed University) Students' Council</b>" (hereafter referred to as <b>NDRISC</b> after the name of the Institute, the National Dairy Research Institute, Karnal.</p>

<p><b>Article 5. Membership</b> Any person who is admitted in NDRI as a B.Tech. (DT), Master degree or Ph.D student will automatically become a member of the NDRISU. “Departmental” students of the Institute are also eligible for the membership of the NDRISU.</p> <p>No person who is not a member of the NDRISU shall make use of the recreational and other amenities in the Students Hostels.</p>	<p><b>Article 5. Membership</b> Any person who is admitted in NDRI as a B.Tech. (DT), <b>Master’s degree or Doctoral degree</b> student will automatically become a member of the <b>NDRISC</b>. “<b>In-Service</b>” students of the Institute are also <b>the members of the NDRISC</b>.</p> <p>No person who is not a member of the <b>NDRISC</b> shall make use of the recreational and other amenities in the Students Hostels.</p>
<p><b>Article 6. Subscription</b> Each member shall pay a sum of Rs.150/- as annual subscription which is non-refundable. For this purpose, the year shall be the same as the academic year of NDRI. Full subscription shall be payable for academic year or a part thereof at the time of Registration. The subscription shall be subject to revision from time to time.</p>	<p><b>Article 6. Subscription</b> Each member shall pay a sum of <b>Rs.500/-</b> as annual subscription which is non-refundable. For this purpose, the year shall be the same as the academic year of NDRI. <b>Full subscription shall be payable for academic year at the time of Registration.</b> The subscription shall be subject to revision from time to time.</p>
<p><b>Article 7. General Body</b> The members of the NDRISU shall constitute the General Body of the Union.</p>	<p><b>Article 7. General Body</b> The members of the <b>NDRISC as given in Article 5</b> shall constitute the <b>General Body of the Council</b>.</p>
<p><b>Article 8. Finance of the Union.</b> <b>Budget:</b> The yearly budget of the Union Fund shall be prepared by the Union Executive in consultation with the Financial Advisor within one month of its election. The budget will be effective after its presentation and approval by the Executive Committee and Staff Advisors meeting chaired by the Patron. <b>NOTE :</b> i. The item of the expenditure shall be clearly shown in the Budget. ii. While preparing the budget the Union Executive shall reserve at least 20 percent of the total fund “On reserve” for unforeseen expenditure, if any. iii. The appropriation or re-appropriation of funds from one head to another may be done by the Union Executive with the approval of the patron on the recommendation of the Financial</p>	<p><b>Article 8. Finance of the Council.</b> <b>Budget:</b> The yearly budget of the Council Fund shall be prepared by the Council Executive in consultation with the Financial Advisor within one month of its election. The budget will be effective after its presentation and approval by the Executive Committee and Staff Advisors meeting chaired by the Patron. <b>NOTE :</b> i. The item of the expenditure shall be clearly shown in the Budget. ii. While preparing the budget the Council Executive shall reserve at least 20 percent of the total fund “On reserve” for unforeseen expenditure, if any. iii. The appropriation or re-appropriation of funds from one head to another may be done by the Council Executive with the approval of the patron on the recommendation of the Financial</p>

<p>Advisor.</p> <p><b>Accounts:</b> The funds of the Students' Union shall be maintained by the clerk under supervision of the Financial Advisor. The clerk maintaining the accounts will be paid suitable honorarium per month.</p> <p><b>Bank Accounts:</b> The funds of the Students' Union shall be kept in a current/savings bank/fixed deposit account with a scheduled Bank of India in the name of the Union and operated by the Financial Advisor. Two faculty members (nominated by Patron) will be authorized to sign the cheque for any transaction from the accounts and two signatures will be necessary, one of the signatories must be the Financial Advisor.</p> <p><b>Audit of Accounts</b> The account of annual expenditure of the NDRISU shall be audited by officer appointed by the Patron. Each payment out of Union Fund shall be approved by the Financial Advisor. The Accounting year for NDRISU will be closed on 30th June every year.</p>	<p>Advisor.</p> <p><b>Accounts:</b> The funds of the Students' Council shall be maintained by the <b>clerk posted at University Office under supervision of the Financial Advisor.</b></p> <p><b>Bank Accounts:</b> The funds of the <b>Students' Council</b> shall be kept in a current/savings bank/fixed deposit account with a Scheduled Bank of India <b>in the name of the Council</b> and operated by the Financial Advisor. Two faculty members (nominated by Patron) will be authorized to sign the cheque for any transaction from the accounts and two signatures will be necessary, one of the signatories must be the Financial Advisor.</p> <p><b>Audit of Accounts</b> The account of annual expenditure of the <b>NDRISC</b> shall be audited by <b>an officer</b> appointed by the Patron. The member so accused will be given full opportunity to defend himself/herself. The decision of the Chief Patron/Patron shall be final.</p>	<p>In case a member of the Executive Committee is alleged to have committed a breach of the constitution or is charged with a serious offence, such as defalcation of funds or misappropriation of the <b>Council</b> property, the <b>Council Executive</b> shall after investigation and with its own findings and opinion forward the case to the Patron for such action as he/she may deem fit. <p><b>Article 13b. Eligibility to contest election in any Capacity</b>  A student of the Deemed University Teaching Divisions shall be eligible to contest in any capacity of the NDRISU, if :</p> <ul style="list-style-type: none"> <li>i) He has not failed in the preceding examinations; or has not failed more than twice in his total academic career in NDRI.</li> <li>ii) He is not involved in a criminal case or a case of moral turpitude or of gross misconduct or misbehaviour.</li> <li>iii) He is not a defaulter in the payment of university dues.</li> <li>iv) He has not been an office bearer of the NDRISU for two consecutive years.</li> </ul> <p><b>NOTE : A student will be guilty of gross misconduct if he/she :</b></p> <ul style="list-style-type: none"> <li>i) is expelled from the University/Hostels or is fined.</li> <li>ii) is placed on conduct probation.</li> <li>iii) is convicted of a non-bailable offence.</li> <li>iv) is found guilty of adopting unfair means in the University Examinations.</li> <li>v) has brought bad name to the University by his misconduct on or outside the campus as determined by the competent authority of the University.</li> <li>vi) destroy University property, mutilates or involves himself/herself in theft of Library Books, and</li> <li>vii) prevents any University Official from performing his/her normal duties or assaults/intimidate any employee of the University.</li> </ul>	<p><b>Article 13b. Eligibility to contest election in any Capacity</b>  A student of the <b>NDRI Deemed University</b> shall be eligible to contest in any capacity of the <b>NDRISC</b>, if :</p> <ul style="list-style-type: none"> <li>i) <b>He is not guilty of gross misconduct.</b></li> <li>ii) He is not involved in a criminal case or a case of moral turpitude or of gross misconduct or misbehaviour.</li> <li>iii) He is not a defaulter in the payment of university dues.</li> <li>iv) He has not been an office bearer of the <b>NDRISC</b> for two consecutive years.</li> </ul> <p><b>NOTE : A student will be guilty of gross misconduct if he/she :</b></p> <ul style="list-style-type: none"> <li>i) is expelled from the University/Hostels or is fined.</li> <li>ii) is placed on conduct probation.</li> <li>iii) is convicted of a non-bailable offence.</li> <li>iv) is found guilty of adopting unfair means in the University Examinations.</li> <li>v) has brought bad name to the University by his misconduct on or outside the campus as determined by the competent authority of the University.</li> <li>vi) destroy University property, mutilates or involves himself/herself in theft of Library Books, and</li> <li>vii) prevents any University Official from performing his/her normal duties or assaults/intimidate any employee of the University.</li> </ul>

If such a motion is duly carried, the meeting shall be adjourned.</p> <p><b>ii) Vote of No Confidence</b></p> <p>a) A vote of no confidence may be brought against any member of the Executive for violation of constitutional provisions, neglect of duty or unbecoming conduct if 40% of the members of <b>NDRISC</b> send a requisition of the same to the Patron and if the latter agrees to the validity of the grounds on which the requisition is based, he shall allow it to be moved. It shall be considered effective only when a simple majority of the members present in the</p>

The notice for such a motion shall be issued atleast a week in advance of the meeting of the Executive of the NDRISU.</p> <p>b) In case of class representatives, lack of confidence may be expressed by class itself. In such a case at least 40% of the students of the class shall be required to send a requisition to the Patron intimating their desire for the recall of the representative. If the Patron agrees to its validity and allows the motion, he will arrange to call a class meeting and decide the issue by a simple majority vote. At least 3/4 of the members of that class shall constitute the quorum of such a meeting.</p> <p><b>iii) Amendments</b> The provisions of the Constitution may be amended if required by a committee of Faculty Members appointed by the Patron.</p> <p><b>iv)</b> If the Chief Patron/Patron finds that the Union, on account of group rivalries or any other reason, has been unable to function, he may supersede the Union and appoint a Committee of five students to carry on the functions of the Union for such period as may be deemed fit and necessary, under the supervision of Staff Advisors and financial Advisor.</p> <p><b>v)</b> If NDRISU Executive Committee does not function as per the Constitution, the Chief Patron/Patron reserves the right to dissolve the NDRISU Executive Committee, whose decision shall be final.</p> <p><b>vi) Interpretation of the Constitution</b> Any dispute relating to the interpretation of the constitution shall be settled by the Chief Patron/ Patron whose decision shall be final.</p>	<p>Executive Meeting of the <b>NDRISC</b> approve it in an extraordinary meeting.
